**AGREEMENT ON ACADEMIC AND RESEARCH COOPERATION  
BETWEEN  
TRIPURA UNIVERSITY, INDIA  
AND  
BANGABANDHU SHEIKH MUJIBUR RHAMAN AGRICULTURAL UNIVERSITY  
BANGLADESH**

This Agreement on Academic and Research Cooperation (hereinafter referred to as "this Agreement") is made and entered into 4 September 2022 (hereinafter referred to as the "Effective Date") between Tripura University, a Central University duly organized and existing under the laws of India, having an address at Suryamaninagar, Tripura, India (hereinafter referred to as "TU") and Bangabandhu Sheikh Mujibur Rahman Agricultural University, having an address at Gazipur, 1706, BANGLADESH (hereinafter referred to as "BSMRAU") (TU and BSMRAU may be referred to individually as the "Party" and jointly as the "Parties") to promote academic and Research cooperation.

1. The purpose of this Agreement is to develop scientific, academic, research and educational cooperation on the basis of equality and reciprocity and to promote relations between TU and BSMRAU under the mutual understanding between the Parties (hereinafter referred to as the "Academic and Research Cooperation").
2. The Parties undertake necessary action to promote and develop the Academic and Research Cooperation as follows:
  - i. Exchange of academic staff and students;
  - ii. Plan and execute joint research;
  - iii. Exchange of Academic and Research information and publications;
  - iv. Organize joint Seminar, Conference, Workshop, Symposium, etc. and
  - v. Other academic and research exchanges to which both Parties agree.
3. The Parties shall execute any written agreement for each detailed activity for promoting and developing the Academic and Research Cooperation.
4. This Agreement is not intended to be legally binding. Nothing, therefore, shall diminish the full autonomy of either Party, nor shall any constraints to be imposed by either Party upon the other Party in carrying out this Agreement.
5. This Agreement shall come into effect on the date of signing and shall be valid for a period of five (5) years. This Agreement may be renewed, revised or modified after discussion by representatives of both Parties. This Agreement shall be terminated by a six (6) month prior written notice of the Party.
